

Outboard engines are a favorite object of some thieves. Therefore, outboard motors have to be securely bolted to the vessel by an anti-theft device. Make sure to choose a lock in proportion to the value of the engine. According to our experience, cheap and simple locks do not keep thieves away from your belongings. An anti-theft device in a very low price range is for sure not the right choice to secure a high-range outboard engine. And the insurer will not accept such devices in case of a claim. There are special locks by named manufacturers which are available in several categories, so your engine is as safe as possible if choosing the right device. The more expensive and valuable the engine the more you should invest in your theft device.

> Covid-19 this job." // Elke Spinneker **CHARTER MARKET TURNED UPSIDE DOWN** 2020 has been a rough season. There is uncertainty among the crews on their booked destinations, and also trips are still being canceled due to current travel warnings. Many clients ask for the insolvency insurance cover, which can be signed in combination with our travel cancellation insurance. Please note that these insurances have to be arranged with the booking, at the latest within 14 days. If your trip is rebooked due to COVID-19, your travel cancellation insurance and your insolvency insurance are also rebooked free of charge if the charter trip takes place until Dezember 31, 2020. Travel cancellation and insolvency insurances to a travel contract which is rebooked to a period in 2021 will be charged with an extra premium of 50% to the original premium because of the longer period of insurance cover. Charter Deposit Insurances keep their booked cover if the trip takes place until the end of 2021. Your skipper third party liability insurance might be rescheduled up to 12 months, your booked skipper's passenger insurance cover might be rescheduled up to 36 months.
